FULL-SCAN POPULATION

171,863 PTSD ISSUES SCANNED

Published Board issues coded under diagnostic code 9411.

OVERLAPPING MARKERS

One issue may contain several markers. Counts cannot be added together and are not shares of mutually exclusive stressor types.

CATEGORY 1

LEGAL STRESSOR PATHWAYS

These are the only two detected markers in this dataset that describe the legal pathway or stressor context itself.



COMBAT PATHWAY

COMBAT DECORATIONS OR 1154(B)

References to combat decorations or the statutory combat-evidence rule.

CATEGORY 2

VERIFICATION-RECORD MARKERS

These describe evidence used to research or corroborate an event, not the event itself.

UNIT RECORDS, MORNING REPORTS, OR DECK LOGS

Operational and historical records used to investigate claimed events.

CATEGORY 3

STRESSOR CONCEDED, VERIFIED, OR CORROBORATED

This marker describes the Board record's conclusion about stressor proof. It is not a separate stressor category.

IMPORTANT LIMITATION

THIS IS NOT A STRESSOR POPULARITY CHART

The categories are not mutually exclusive. The same issue may mention a legal pathway, unit records, JSRRC research, and a conceded stressor.

Absence of a marker does not mean absence of a stressor. It means the selected term pattern was not detected.

Several stressor types are not separately counted here. The source does not provide comparable categories for MST, personal assault, accidents, or other non-combat events.

RESEARCH TAKEAWAY

STRESSOR CONTEXT AND STRESSOR PROOF ARE DIFFERENT VARIABLES

Combat and fear-of-hostile-activity markers describe legal routes. Unit records and JSRRC describe verification methods. A conceded or corroborated stressor describes the resulting finding. Keeping these layers separate avoids a misleading comparison.



SOURCE AND SCOPE

RateMyVSO analysis of 171,863 published Board issues coded for PTSD under diagnostic code 9411. Data generated August 10, 2026. Drawn from a research corpus containing more than 1.9 million published BVA decisions. Marker counts overlap and do not predict an individual claim outcome.
